PRIVACY POLICY

- 1. The present Privacy Policy was developed by "Doping Space" Limited Liability Company (TIN 02893152, location apt. 58, 25a Nalbandyan Str., c. Yerevan), hereinafter referred to as "Company", and regulates relations in view of the use of personal data by the Company on this website (hereinafter referred to as "Website"). Relations in view of the Privacy Policy are regulated by RA legislation.
- 2. The Privacy Policy defines how the Company uses the personal data collected thereby while using the Website.
- 3. All terms used on the Website have the meanings defined by RA Law on Protection of Personal Data (hereinafter referred to as "Law")

According to the Law, <u>any information relating to a natural</u> <u>person that allows or can allow to identify a person directly or indirectly is considered personal data.</u>

The terms "data", "information" are used on the Website with equivalent meaning. Checking the box to accept the terms of the Privacy Policy means consent to the processing of your personal data with the purposes stipulated by this policy.

4. How does the Company collect information?

The Company collects information by the following means:

- When you use any service offered on the Company Website entering your personal data;
- When you register online or buy a ticket;
- When you subscribe for news;
- When you fill out the form "Feedback";
- When you fill out the customer inquiry voluntarily, leave a message on the Website or send an email;
- When you visit, use or examine the Website by means of the cookies of your browser (in this case the information is stored in "Cookies" section).

Information in regard to you received by the above listed means are deemed to be personal data.

5. What personal data does the Company collect?

The Company collects information (personal data) needed to achieve the purposes of processing your data determined by this Privacy Policy to render any service, received from IP addresses and stored in the "Cookies" section, in particular:

- First name, last name;
- Electronic mail address;
- Telephone number.

Your personal data becomes available from the moment of registration on the Website. Receiving data from IP addresses and storing thereof in the "Cookies" section starts automatically at the moment when you visit the Company Website.

6. How does the Company use your data?

The Company may use data collected from you by means of registration, subscription to the news, using the form "Feedback" or the Website in another way with the following purposes:

- To render services to you within the frames of Company activities;
- To render services suggested on the Company Website;
- To process your order;
- To address the payments made by you online;
- To send new suggestions of the Company, discount possibilities and other information on the Company's services;
- To send special offers on other products and services to the e-mail address which in the opinion of the Company may interest you;
- With the purpose of increasing the service quality to improve the Website;
- To provide service quality corresponding to customer requirements;
- To respond to your request to contact you.

The information provided by you are stored in the data bank which is refreshed every time new information is received. When you cease subscription, your data is stored in the list of stopped subscribers.

7. How does the Company store and protect your data?

The Company stores your data in the secure server https://sendpulse.com/. The data transmission is performed by secure socket layer (SSL) technology.

The Company will take all technical and organizational measures necessary and equivalent for data security provision to ensure the inviolability of your data. The Company applies respective technical and institutional measures to protect your personal data from unlawful interference. Despite this, you should be aware that the possibility of such interference cannot be totally excluded. Nevertheless, the Company undertakes to perform its obligations under the Law.

Your personal data are in protected networks and are accessible only for a restricted number of people (Company employees) who have special rights of accessibility to the mentioned systems and are obliged to preserve the privacy of the indicated information.

While providing personal information by any user the Company applies a number of security measures.

8. What are your data protection rights?

Each user is entitled to:

- Get acquainted with personal data and receive information thereon;
- Demand correction of personal data;
- Demand destruction of personal data;
- Demand blocking.

9. The Company is obliged to:

- Not to use false or misleading headlines or electronic addresses;
- If a message is an advertisement, reasonably qualify it as such;
- Immediately respond to unsubscribe requests;
- Enable the Users to unsubscribe by clicking the link at the end of each email.

10. Does the Company use the "cookies" section?

Yes! "Cookies" are small files which any Website or service provider sends to the hard disk of your computer through a web-browser (in case

you permit it), and which allow the systems of this Website or service provider to recognize your browser and catch and remember certain information. They help to understand your preferences based on your former and current actions performed on the Website, which in its turn enables to improve the quality of service rendered to you.

11. The Company uses the "cookies":

- To understand and remember the Users' preferences for future visits;
- To track advertising;
- For integrity of data on website use and quantity of visits to improve the Website quality and develop new tools in the future. The Company also can make use of services of reliable third parties, which will track the mentioned information on behalf of the Company.

12. How does the Company use the "cookies"?

The Company uses the cookies in different ways including by means of keeping you "logged in" on the Website.

13. What kind of cookies does the Company use?

There are different types of cookies. The following type is used on the Website;

Functionality: the Company uses these cookies to recognize you on the Website and remember the preferences made by you in the past. They may remember, in particular, the language you prefer and the place where you are. Both own and outside cookies are used.

14. How to manage the cookies?

You can regulate your browser so that it doesn't accept cookie files.

You can choose such a setup that each time the Website sends you a "Cookie" your computer informs you about it or just switches off all Cookies. This is done by means of browser adjustments. As browsers slightly differ from one another, try to perform necessary changes connected with the Cookies through the "Help menu" section of the browser.

The Company accepts the "Unfollow" signals and does not follow your browser, does not send Cookies or apply these with advertising purposes if the browser "Unfollow" function is activated.

In case of switching off the Cookies, some functions of the Website may be suspended.

15. Providing information to third parties

The Company, without receiving your prior consent, shall not sell or otherwise transmit your personal data to third persons, including companies, organizations that are the Company's partners and that do not appear as the Company's authorized persons. The Company partners providing the Website hosting and other persons that assist the Company in the matter of Website exploitation, carrying out activities, service of users, are the authorized persons of the Company, which process the personal data only within the frames of the task. The Company may also disclose the information in cases defined by legislation from considerations of application of Website policies, preservation of rights, property or safety of the Company or others.

The Company does not permit any third party to carry out study of behavior of the users within the Website domain.

16. Third party links

The Company Website may include or suggest third party products and services.

The Company's Privacy Policy is applicable only on the Company Website. Thus, if you go through a link of another website, you should get acquainted with the Privacy Policy of that website.

17. Making changes

The Company regularly reviews and edits the Privacy Policy posting all updates on the Website. The Company reserves the right, at its sole discretion, to unilaterally modify its Privacy Policy at any time and for any reason without prior notice. New modifications are applicable towards you if you have given your consent to the data processing on new conditions (with modifications).

18. Terms of personal data storing

Your personal data are stored for three years after using the Company services for the last time or till the expiration of the three-days' term after you have filed an application on destroying your personal data.
